This INDENTURE made the twenty eighth Day of Ju-  
ly in the year of Our Lord one thousand eight hundred and ten  
between William House of the town of Warwick in the County of Or-  
ange and State of New York of the one part <sup>and</sup> Hannah Weymer of the  
town of Chесcock in the County of Orange and State of New York of  
the other part witnesseth that the said William House for and  
in consideration of the sum of forty four Dollars to him in hand paid  
by the said Hannah Weymer the receipt whereof is hereby acknowledged  
doth grant bargained and sold remised released and quit claimed  
and by these presents doth hereby bargain sell demise release and  
quit claim unto the said Hannah Weymer (in her usual professional  
being) and to her heirs and assigns forever all that certain tract of land  
situate situate in the County of Orange and between the State of New  
Jersey and the line established for the south bound of the Patent of Chес-  
cocks and bounded as follows Beginning at the west Edge of the Orange  
Turnpike Road at the distance of five Chains and twenty five Links south-  
westerly from the Nothernly end of Man of War Rock in the line of a  
tract formerly bought by Michael Weymer and runs thence along the  
last mentioned line south forty eight degrees east thirty four chain  
to a heap of stones then south seventeen degrees west forty chains to two  
Walnut saplings marked and stones put to them for a corner of the tract  
laid out for Thomas Sanford then along the lines thirty nine North  
forty eight degrees west twenty chains to a heap of stones and south twenty

Nine degrees west Eight Chains to the Edge of Bramapough Leas and  
 then down the middle of the stream south two degrees west twelve Chains  
 and south twenty four degrees east twenty two Chains and south twenty  
 two degrees west twelve Chains and thence North eighty degrees west  
 six Chains to a heap of stones on the west edge of the said Turnpike  
 Road and south fifty four degrees west twenty three Chains to a  
 white Oak tree and south thirty degrees west ten Chains to a heap of  
 stones in a line of said Michael Waynes said tract then along the  
 same North forty eight degrees west seventeen Chains thence North  
 thirty degrees East Ten Chains to a heap of stones on a Rock then  
 North twenty three degrees east seventeen Chains to a white Oak tree  
 then North thirty two degrees west Eighteen Chains to a corner of the  
 third tract laid out for Henry Weston House along the line thereof north  
 eighty four degrees east thirty one Chains to the said Turnpike Road  
 and then along the same North two degrees West sixteen Chains and  
 thence south eighty four degrees west twenty four Chains to the line of  
 said Michael said Tract then along the same North forty two degrees  
 East thirty two chains to a hickory stump on a high ledge of Rocks then  
 south forty eight degrees east Eight Chains to the beginning containing  
 two hundred and twenty acres Together with all and singular the  
 hereditaments and appurtenances thereto belonging or in any wise  
 pertaining and the reversion and reversions remainder and remain-  
 ders rents, issues and profits thereof And all the Estate Right-fell  
 mortal Clains and Demand whatsoever of him the said William House either  
 in Law or Equity of us and to the above bargained premises and every part and  
 parcel thereof to have and to hold the said above mentioned and Described pre-  
 mises and every part and parcel thereof to the said Hannah Heymer her heirs and  
 assigns for ever In witness whereof the said William House hath hereunto set his  
 hand and seal the day and year first above written
